
Account Changes

Issue: How to change login email

Solution:

1. Click My Profile -> Click Change Login Email -> Enter the New Email Login

Employee ID

Issue: Unable to verify my employee ID as a new hire

Solution: If you are a new employee, we advise new employees to try to verify their employee ID after their start/entry date, as by then, the employee ID will be in the system.


If prompted to verify your employment, please select **Remind Me Later** for the time being. You should be able to register/access most courses without verifying your employee ID.

Issue: Unable to verify my employee ID as an employee who is not directly under a B.C. health organization

Solution: Employees who are not directly under a B.C. health organization cannot verify their employee IDs. Most likely you will need to update your account type to an Affiliate.

If prompted to verify your employment, please select Remind Me Later to complete the profile first. Then go to My Profile -> Change Account Type.

Have there been any changes in your job or any missing data?

Issue: Incorrect profile employment information associated with employee ID

Solution:

1. New position: if you have changed positions but have the same employee ID, your profile information will automatically update shortly after your start date.

2. **Multiple job positions**: if you have multiple positions under the same employee ID, only one position can be displayed. To request to change the displayed job information, submit a **Learner Support** ticket: <u>http://learninghubhelp.phsa.ca/contact</u>.

3. **New employee ID**: if you need to change the employee ID verified under your profile, submit a **Learner Support** ticket: <u>http://learninghubhelp.phsa.ca/contact</u>.

Course Information

Issue: Unable to display the course content due to an error page/blank screen/Flash Player

Solution: If you are viewing a **blank screen**, or receive a **Flash Player** notice when opening a course, please try opening the course through an Incognito Window on Google Chrome to clear your cache. Issue: Course module is not being marked as complete


Solution:
